Extreme Weather events impact service in Adelaide

Telstra is working to manage the significant impact to Telstra services that has occurred as a result of a series of extreme weather events in the Greater Adelaide region of South Australia, on or about Monday 5 April 2010 through to Tuesday 6 April 2010.

Due to the effect of damage to Telstra telecommunications network by a severe weather system, there has been a significant increase in the number of Telstra services being reported as faulty. As a result, there has been some disruption to service and delays to normal installation and repair activities.

Telstra apologises to any affected customers.

Information as to the nature of these severe weather events can be sourced from Weatherzone. Heavy rainfall and flooding referred to in Weatherzone media articles issued on Tuesday 6 April 2010 initially at 10:58 EST Tuesday 6 April 2010; all of which were widely reported in the news media after the events. Evidence of these events can be sourced from weatherzone.com.au.

Telstra has identified that the effect of these circumstances applies to approximately 3353 services. This number may increase as Telstra assesses the full affect of the extreme weather conditions. Based on current information, the resumption date of normal service operations is expected to be 16 April 2010. This date is indicative only; Telstra customers should anticipate that some further delays may occur. Telstra regrets any inconvenience caused to customers and thanks them for their patience while this work is being undertaken.

Telstra services encompassed in this exemption are; in the area bounded by and including, but is not limited to the area starting at Rosedale, go southwest to Gawler, south to One Tree Hill, southeast through Kersbrook to Birdwood, south to Mt Torrens, southwest to Woodside, southeast to Brukunga, south to Dawesley and southwest to Wistow. From Wistow the area boundary continues west to Echunga, northwest to Bradbury, south southeast to Kangarilla, southwest through McLaren's Flat to Aldinga, west southwest to Aldinga Beach, then following the coastline north past Henley Beach to Lower Light, then go east past Reeves Plains and Roseworthy back to Rosedale. All suburbs, towns, off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed in this exemption.

As these circumstances were outside of Telstra's control, Telstra is claiming an extension to time frames applying under the *Telecommunications (Customer Service Guarantee) Standard 2000 (No.2)*. This means that Telstra is notifying customers that normal service time frames may not be met during the period of **7 April 2010 to 16 April 2010** inclusive (based on Telstra's estimated recovery schedule correct at the time of publication of this notice).
