Terms used in this Report

In this report, the terms *Telstra*, the *Telstra Group* and the *Company*, refer to Telstra Corporation Limited, a corporation organised under the laws of the Australian Capital Territory, Australia, and its controlled entities as a whole; the expression *Telstra Entity* is used to refer to the legal entity Telstra Corporation Limited. *Telstra** is a registered trademark of Telstra. The term *Commonwealth* refers to the Commonwealth of Australia and the term *Government* refers to the Government of the Commonwealth of Australia.

The term *Shares* refers to the ordinary shares of the Telstra Entity; *Instalment Receipt* or *IR* refers to the receipt issued by the Trustee (as defined) evidencing beneficial ownership of a Share pending receipt of the Final Instalment; ADS refers to an American Depositary Share which represents 20 Shares; ADR refers to an

American Depositary Receipt evidencing an ADS; Interim ADS refers to an Interim American Depositary Share, which represents 20 IRs; and Interim ADR refers to an Interim American Depositary Receipt evidencing an Interim ADS.

Telstra's fiscal year ends on June 30. Reference in this report to a *year* or to a *fiscal year* is a reference to the year ended June 30 unless otherwise stated; reference to *1998* in this report is a reference to fiscal 1998 and other fiscal years are referred to in a similar manner unless otherwise stated.

All amounts are expressed in Australian dollars (A\$) unless otherwise stated.

A Glossary of other terms used is provided to assist with the general understanding of this report. (See Contents page 1).
