## Customer Service Guarantee Exemption Advice —20240117-WA-S-C-I-LOWER WEST AND CENTRAL WHEAT BELT DESTRICTS EXT

We've previously advised of an interruption to Telstra's normal operations, due to parts of the South Coast, Great Southern and Central Wheat Belt distracts for Western Australia was impacted by extreme storms resulting in major local power outages between 16<sup>th</sup> January 2024 to 22<sup>nd</sup> January 2024.

We are continuing to experience ongoing delays in installation and repair activities due to this event We estimate that as many as 629 Telstra services may be impacted.

## How will this affect you?

We anticipate that most services will be restored by 15<sup>th</sup> March 2024. We're sorry for any inconvenience this delay may cause but we can assure you we are working hard to get things back on track.

In the event this timeframe is extended, a revised notification will be provided.

## What else do you need to know?

Due to this event, we're claiming an exemption under section 24 of the Telecommunications (Customer Service Guarantee) Standard 2023, including an exemption from the payment of compensation between 17<sup>th</sup> January 2024 to 15<sup>th</sup> March 2024 inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.

The exemption process is explained in sections 24–30 of the *Telecommunications (Customer Service Guarantee) Standard 2023*, which can be found on the <u>Australian Government</u>, <u>Federal Register of Legislation</u> website.
