#### \*\* About the reference price comparison

Electricity retailers are required to demonstrate to customers in NSW, SA and Southeast QLD how their electricity rates compare to a benchmark "Reference Price" set by the AER for a representative (or, average) customer. The Australian Energy Regulator (AER) determines a reference price for each distribution area and for specified tariff types based on the amount of electricity the AER considers the average household would consume each year. The usage and cost figures in the reference price comparisons are estimates only and your electricity costs may be significantly different depending on your actual usage. Similar reference prices exist in Victoria, which are determined by the Essential Services Commission.
