

CUSTOMER SERVICE ADVICE FROM TELSTRA

Extreme Weather events impact service in Perth and Lower West region of Western Australia

Telstra is working to manage the significant impact to Telstra services that has occurred as a result of a series of extreme weather events in the Perth and Lower West region of Western Australia on or about Friday 20 January 2012.

Due to the effect of damage to the Telstra telecommunications network by severe thunderstorms, there has been a significant increase in the number of Telstra services being reported as faulty. As a result, there has been some disruption to service and delays to normal installation and repair activities.

Telstra apologises to any affected customers.

Information as to the nature of these severe weather events can be sourced from the Bureau of Meteorology (BOM). Heavy rainfall, flash flooding and damaging winds are referred to in the BOM Severe Weather Warning issued for 20 January 2012 initially at 7:30 am on Friday 20 January 2012; all of which were widely reported in the news media after the events.

Telstra has identified that the effect of these circumstances may apply to approximately 4500 services. Some of these services may not be installed or repaired within Telstra's standard time frames. The number of possibly affected services may increase or decrease as Telstra assesses the full effect of the extreme weather conditions. Based on current information, the resumption date of Telstra's normal service operations is expected to be 8 February 2012. This date is indicative only, however, and may be subject to change once the full impact of the extreme weather conditions has been assessed. Telstra regrets any inconvenience caused to customers and thanks them for their patience while this work is being undertaken.

Telstra services encompassed in this exemption are in the area bounded by and including, but are not limited to the area starting at Lancelin on the WA coast head east north east through Lake Hinds to Beacon. Then go south through Bencubbin, Trayning to Kellerberrin. From Kellerberrin head southwest through Quairading, Brookton, Wandering to Boddington. Then go south through Marradong, Bowelling to Dinninup. Then go east to Balingup. From Balingup head northeast through Kirup to Donnybrook. Then go east to the WA Coastline of Geographe Bay. From Geographe Bay on the WA coastline head north past Binningup, Preston Beach, Mandurah, Rockingham, Fremantle, Perth, Quinns Rocks and continue following the coastline north back to Lancelin. All suburbs and towns, off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed in this exemption.

As these circumstances were outside of Telstra's control, Telstra is claiming an exemption from compliance with time frames and performance standards required under the *Telecommunications (Customer Service Guarantee) Standard 2011*. Therefore Telstra is notifying customers that normal installation and repair time frames may not be met during the period from **23 January 2012 to 8 February 2012** inclusive (based on Telstra's estimated recovery schedule correct at the time of publication of this notice) and, under section 21 of the *Telecommunications (Customer Service Guarantee) Standard 2011*, Telstra will be exempt from complying with performance standards during this period.
