

# Customer Service Advice from Telstra

## **Extreme Weather events impact service in Canberra and the surrounding Australian Capital Territory District.**

As previously notified by Telstra on Wednesday 10 December 2014, Telstra's normal operations in the Canberra and the surrounding Australian Capital Territory District were affected by a series of extreme weather events on or about Wednesday 3 December 2014 through to Thursday 4 December 2014. Telstra's telecommunications network in these areas have experienced high levels of damage that resulted in delays to installation and repair activities on a significant number of Telstra services. Due to the extent of damage to the Telstra network, the impact in the affected region has been greater than initially estimated, and as a consequence of the continued weather effects, the expected recovery date has now been extended to 11 January 2015.

Telstra has identified that the effect of these circumstances applies to an additional 1,300 services bringing the total number of services impacted to approximately 2,500 services. This number may increase as Telstra assesses the full affect of the extreme weather conditions. Based on current information, the resumption date of normal service operations is expected to be 11 January 2015. This date is indicative only; Telstra customers should anticipate that some further delays may occur. Telstra regrets any inconvenience caused to customers and thanks them for their patience while this work is being undertaken.

Telstra services encompassed in this exemption are in the area bounded by and including, but not limited to, the area starting at Nerriga then heading southwest past Braidwood and Jerangle to Bunyan. The area then turns northwest to Batlow, northeast past Brindabella to Murrumbateman then east back to Nerriga. All suburbs and towns serviced by Telstra within these boundaries are encompassed in this exemption.

As these circumstances were outside of Telstra's control, Telstra is claiming an extension to time frames applying under the *Telecommunications (Customer Service Guarantee) Standard 2011*. This means that Telstra is notifying customers that normal service time frames may not be met during the period of **4 December 2014 to 11 January 2015** inclusive (based on Telstra's estimated recovery schedule correct at the time of publication of this notice).
