

# Customer Service Advice from Telstra

## **Delay due to extreme weather events in the Herbert and Lower Burdekin District and parts of the Northern Goldfields and Upper Flinders District, North Tropical Coast and Tablelands, and Central Coast-Whitsundays Districts of Queensland.**

As previously notified by Telstra on 4 March 2019, Herbert and Lower Burdekin District and parts of the Northern Goldfields and Upper Flinders District, North Tropical Coast and Tablelands, and Central Coast-Whitsundays Districts of Queensland were impacted by extreme weather on or about Thursday 24 January 2019 through to Wednesday 30 January 2019, with areas of Queensland declared as a Natural Disaster. This event resulted in extensive damage to Telstra's network, the impact in the affected region has been greater than initially estimated, and as a consequence the expected recovery date has now been extended to 14 April 2019.

The effect of the natural disaster and extreme weather events applies to an additional 600 services bringing the total number of services impacted to approximately 4,850 services. This number may increase as Telstra assesses the full effect of the extreme weather events. Based on current information, the resumption date of normal service operations is expected to be 14 April 2019.

Telstra services encompassed in this exemption are in the area bounded by and including, but are not limited to the area starting at Deeral following the coastline past Innisfail, Townsville and Bowen to Skull Knob Conservation Park. From Skull Knob Conservation Park the area turns west to Macartney State Forest, southwest to Mount Coolon, and west to Kynuna then north to Croydon. The area heads southeast to Northhead, northeast to Innot Hot Springs then northwest to Mount Mulligan. From Mount Mulligan the area turns east to Kuranda, south to Danbula then east back to Deeral. All suburbs and towns off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed in this exemption.

### **How will this affect you?**

Unfortunately your service may be affected and we may take longer than normal to fix telephone services or complete connections. Services in the area mentioned above with phone numbers in the following number ranges may have been affected:

We anticipate that the majority of services will be restored by 14 April 2019. We're sorry for any inconvenience this delay may cause but we can assure you we are working hard to get things back on track.

### **What else do you need to know?**

Information as to the nature of these extreme weather events and the Natural Disaster event can be sourced from the Bureau of Meteorology (BOM) and Ministry for Police & Emergency Service; Queensland. Major flooding has occurred in some parts of the aforementioned districts and flood warnings continue to be issued in other areas; all of

which are widely reported in the news media of these events 24 January 2019 initially at 10:59am, Thursday 24 January 2019, reference number IDQ21037.

Due to this event, we're claiming an exemption under section 21 of the *Telecommunications (Customer Service Guarantee) Standard 2011*, including an exemption from the payment of compensation between **30 January 2019 to 14 April 2019** inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.
