

# Customer Service Advice from Telstra

## **Delay due to severe weather events in the Sydney Metropolitan District and part of the Central Tablelands District of New South Wales.**

As previously notified by Telstra on 10 June 2019, the Sydney Metropolitan District and part of the Central Tablelands District of New South Wales were impacted by severe weather on or about Sunday 2 June 2019 through to Tuesday 4 June 2019. This event resulted in extensive damage to Telstra's telecommunications network. Due to the extent of damage to the Telstra network, the impact in the affected region has been greater than initially estimated, and as a consequence of the continued weather effects, the expected recovery date has now been extended to 14 July 2019.

The effect of these circumstances applies to an additional 6,200 services bringing the total number of services impacted to approximately 18,200 services. This number may increase as Telstra assesses the full effect of the severe weather conditions. Based on current information, the resumption date of normal service operations is expected to be 14 July 2019. This date is indicative only; Telstra customers should anticipate that some further delays may occur.

Telstra services encompassed in this exemption are in the area bounded by and including, but are not limited to the area starting at Barrenjoey Lighthouse following the coastline south past Sydney and Cronulla to Stanwell Beach. From Stanwell Beach the area heads north to Lucas Heights, northwest to Holsworthy, north to Chipping Norton Lake, and northwest to Badgerys Creek then west to Jenolan. The area turns north to Rydal, northeast to Marrangaroo, southeast to Richmond, east to Fiddletown, and north to Singletons Mill then southeast back to the Barrenjoey Lighthouse. All suburbs and towns, including Metropolitan Sydney, off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed in this exemption.

### **How will this affect you?**

Unfortunately your service may be affected and we may take longer than normal to fix telephone services or complete connections. Services in the area mentioned above with phone numbers in the following number ranges may have been affected:

## **What else do you need to know?**

Information as to the nature of the severe weather events, which included damaging winds which occurred in the affected regions can be sourced from the Bureau of Meteorology (BOM). The BOM issued Severe Weather Warnings regarding these events commencing from on or about Sunday 2 June 2019 through to Tuesday 4 June 2019. Additionally these unusually severe weather events have been widely reported by most of the news media.

Due to this event, we're claiming an exemption under section 21 of the *Telecommunications (Customer Service Guarantee) Standard 2011*, including an exemption from the payment of compensation between **4 June 2019 to 14 July 2019** inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.
