

# **IPND Charges for Data Users**

### 1. IPND Application Fee (once only)

An application fee of \$3,000 (excl GST) is payable on application. The application fee is charged by the IPND Manager to cover the costs associated with the process of registration of new IPND Data Users. This includes (but is not limited to):

- Assessment of the applicants Application of Intent to Use the IPND
- User setup and system access (IPND User Test & Production)
- Provisioning a Public Number Directory Publisher Data User with Provisional IPND Data
- Operational / Application and Technical support for Data Users.

#### 2. IPND Data Provision Fee

A Data Provision fee of \$0.007 applies per Public Number (excl GST) provided to the Data User with frequency determined by Data User type / requirements:

**Incremental Data Users:** are those who receive regular / ongoing data files from the IPND.

Incremental Data Users include:

- Public Number Directory Publishers (Online / electronic publications)
- Emergency Triple Zero Call Service,
- Law Enforcement Agencies,
- Early Warning / Emergency Alert.

The Data Provision Fee is chargeable once per year following their annual Bulk Data Refresh.

The quantity of Public Numbers charged for the IPND Data Provision Fee is based on the volume of Public Numbers included in their annual Bulk Data Refresh.

**Infrequent Data Users:** are those who receive data files from the IPND infrequently or upon request.

Infrequent Data Users most commonly include:

- Public Number Directory Publishers (Printed publications: frequency of 1 – 2 annually)
- Researchers

The Data Provision Fee is chargeable each time data is provided to the Data User in response to their request.

The quantity of Public Numbers chargeable for the IPND Data Provision Fee is based on the volume of Public Numbers included in each data instalment provided to the Data User.

### IPND Data Provision Fee Example:

If a Data User XYZ Pty Ltd is provided (a Bulk Refresh or data on request) with 9 million Public Number Customer Data records by the IPND Manager, the Data Provision Fee would be \$63,000 (9 million x \$0.007 excl GST).

### **Introductory Offer:**

All newly registered IPND Data Users (Incremental and Infrequent) are eligible for a special introductory rate of \$0.005 per Public Number (excl GST) for the first 12 months of signing their IPND Data Access Agreement documentation.

#### 3. IPND Data Services Fee

A Data Services Fee is applicable for Data Users who have special requirements with regards to the generation of their data (bespoke queries / sampling etc). An example of a bespoke query includes the random selection of Public Numbers within a selected location. eg: 100,000 numbers selected randomly within the location of Melbourne and surrounding suburbs.

These special requirements form a Special Data Access Request, which incur a Data Services Fee.

The IPND Manager will furnish the Data User a quotation based on the negotiated requirements for the Special Data Access Request. If the Data User does not accept the quoted Data Services Fee, the Special Data Access Request will not proceed.
