Customer Service Advice from Telstra

Delay due to severe weather events in the Sydney Metropolitan District and part of the Illawarra District of New South Wales.

The Sydney Metropolitan District and part of the Illawarra District of New South Wales were impacted by severe weather on or about Monday 7 March 2022 through to Tuesday 8 March 2022.

An interruption to Telstra's normal operations has occurred leading to delays in installation and repair activities. As many as 1,500 Telstra services are impacted in the area bounded by and including, but not limited to, the area starting at the Barrenjoey Lighthouse following the coastline south past Sydney and Cronulla to Wattamolla Beach then west to Waterfall. The area turns southwest to Douglas Park, northwest to Oakdale, north to Springwood, and northeast to Yarramundi then west to Box Hill. From Box Hill the area heads northeast past Glenorie to Doughboy Beach then southeast back to the Barrenjoey Lighthouse. All suburbs and towns, including Metropolitan Sydney, off shore islands and coastal areas serviced by Telstra within these boundaries are encompassed.

How will this affect you?

Unfortunately your service may be affected and we may take longer than normal to fix telephone services or complete connections. Services in the area mentioned above with phone numbers in the following number ranges may have been affected:

What else do you need to know?

Information as to the nature of these severe weather events can be sourced from the Bureau of Meteorology (BOM). Heavy Rainfall and damaging winds are referred to in the BOM Severe Weather Warning issued for 7 March 2022 initially at 11:11 am Monday, 7 March 2022, reference number IDN21037; all of which were widely reported in the news media after the events.

Due to this event, we're claiming an exemption under section 21 of the *Telecommunications (Customer Service Guarantee) Standard 2011*, including an exemption from the payment of compensation between **8 March 2022** to **27 March 2022** inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.
