

## **Customer Service Guarantee Exemption Advice – 20250328-QLD-E-C-I-SOUTH EAST COAST DISTRICTS EXT**

We've previously advised of an interruption to Telstra's normal operations, due to parts of the Beaudesert, Brisbane West, Burleigh, Caboolture, Cunningham, South West, Sunshine Coast Districts for Queensland were impacted by severe storm resulting in heavy rainfall exceeding the 10 Year average, flash flooding and road closures between 28<sup>th</sup> March 2025 to 30<sup>th</sup> March 2025. These weather conditions meet one or more of the criteria specified in Schedule 3 of the Telecommunications (Customer Service Guarantee) Standard 2023.

We are continuing to experience ongoing delays in installation and repair activities due to this event We estimate that as many as 374 Telstra services may be impacted.

### **How will this affect you?**

We anticipate that most services will be restored by 20<sup>th</sup> June 2025. We're sorry for any inconvenience this delay may cause but we can assure you we are working hard to get things back on track.

In the event this timeframe is extended, a revised notification will be provided.

### **What else do you need to know?**

Due to the extreme weather conditions, we're claiming an exemption under section 24 of the Telecommunications (Customer Service Guarantee) Standard 2023, including an exemption from the payment of compensation between 28<sup>th</sup> March 2025 to 20<sup>th</sup> June 2025 inclusive for any delays in fixing or connecting services, and the keeping of appointments relating to these activities in the impacted area.

The exemption process is explained in sections 24–30 of the *Telecommunications (Customer Service Guarantee) Standard 2023*, which can be found on the [\*\*Australian Government, Federal Register of Legislation\*\*](#) website.
