INFORMATION ABOUT THE SERVICE

Canvas is a Business App. Business Apps are a range of applications designed to increase business productivity and can be accessed on compatible tablet and mobile devices with an internet connection (Compatible Devices). You can purchase Business App licences from the Telstra Apps Marketplace marketplace.telstra.com

Canvas is a subscription service that converts paper based forms into digital forms and integrates with existing processes to improve productivity and streamline the flow of information. Subscribers can choose from thousands of ready-made templates – or build their own.

Telstra Apps Marketplace

You need an internet connection to access the Telstra Apps Marketplace. To start using the Telstra Apps Marketplace, visit marketplace.telstra.com and create an account.

You need to meet minimum system requirements to use certain applications available on the marketplace, which will be set out on marketplace.telstra.com and Our Customer Terms.

You're responsible for ensuring that you meet these requirements.

What's included

Canvas allows users to:

- convert paper based forms into digital forms
- access a library of ready built Industry based forms
- convert two paper forms that do not exceed three pages of input fields, plus any associated terms and conditions pages into a digital form for no additional charge. Charges apply for conversion of any additional forms after your first two
- if you have chosen the Canvas Professional Plan you will receive one additional paper form (not exceeding 3 pages of input text plus applicable terms and conditions) converted to a digital form for no additional charge
- integration ready options with other apps as detailed on telstra.com/businessapps

What's not

To access Canvas, each user will need to download the applicable Canvas app from their Compatible Device's application store. Data download charges may apply.

In order to integrate Canvas with back-end systems, your system environment must be properly configured and you may need to make changes to your system set-up. You are responsible for the configuration of your system environment and this is not included in your monthly licence fee. If you require system integration, before purchasing licences for Canvas, please contact us to discuss your specific business needs.

Other important information

Each licence can be used on one Compatible Device. If a user wants to access Canvas on several Compatible Devices, additional licences will be required.

You need to purchase a licence for each individual user and also a licence for your Account Administrator.

30 Day free trial on your initial order – All new Canvas licences activated during the initial order will receive the first 30 days free. At the end of the 30 Day free trial you will need to opt into a paid subscription plan. If you do not opt into a paid plan, your service will be automatically suspended for 14 days and if after 14 days you have still not subscribed, your licences will be cancelled.

Optional Add Ons

If you require a fully custom built form you may add the optional Add Ons:

- The Canvas Custom PDF Form allows you to order a fully customised digital form to match your specific business requirements. If you have multiple Custom PDF's that you need created, you will need to order multiple Custom PDF Add Ons.
- The Canvas Premium Support 'Add On' provides you with approximately 20 Hours of Premium Support to be used on a specific project. The hours can be used as needed and there is no expiry period. If you use up your included hours and require more, you can simply order additional Premium Support Add Ons.
