Information about the service

Teletrac Navman GPS Fleet and Asset Management is a solution that uses Telstra's mobile network to provide near real-time vehicle location, mapping, reporting and mobile communication. There is also an option to use the Iridium satellite network when the vehicle or asset is outside of Telstra mobile network coverage areas.

Availability

You can purchase the Teletrac Navman Solution on:

- a month-by-month casual basis with an upfront purchase of the Teletrac Navman hardware;
- a Hardware Repayment Option where you pay off your Teletrac Navman hardware in monthly installments over 36 months; or
- an Accessory Only Option where you may separately buy supporting hardware;
- Fuel Tax Credit Manager software on a 12-month minimum term;
- Heavy Vehicle Compliance Assistant software on a 12-month minimum term.

Hardware

The Teletrac Navman devices are compact, solid, all-in-one units that are discreetly installed into a vehicle or asset to provide a near real-time location, speed and direction. You need to have the hardware device in order to use the Teletrac Navman solutions.

Hardware options include:

- Qube, Qtanium or iFace devices
- Mobile Data Terminal (MDT)
- Mobile Navigation Terminal (MNAV)
- Satellite Communications Unit (Satellite)
- Data Capture Unit (DCU)
- Hummingbird
- Inovonics
- OBDII Canbus reader
- NavCAN 1 and 2

Minimum term

If you take up the month to month option, there's no minimum term.

If you take up a minimum term for software, hardware or accessories, a minimum term and Early Termination Charges (ETC's) apply.

What's included

Casual Option

- A month-by-month contract for the Teletrac Navman software application(s) except in the case of the iFace which requires the Compliance Pack for a minimum of 12 months.
- Upfront payment for hardware and other costs.

Hardware Repayment Option

- A month-by-month contract for the Teletrac Navman application(s).
- A 36-month contract for the repayment of hardware and other components paid in monthly installments.

Accessory Only Option

An accessories only option where you separately buy supporting hardware.

Fuel Tax Credit Manager Software

- FTC Manager software can be purchased on a 12 month minimum term.

Heavy Vehicle Compliance Assistant

- Heavy Vehicle Compliance Assistant software can be purchased on a 12 month minimum term.

What's not included

- Mobile Data
- Installation with Accessory Only purchases, with the Qtanium and Qube devices, Satellite Communications Unit or Casual Options. Except for purchases set out below.

Important Conditions for Satellite Communications Unit

In order to use the Satellite Communications Unit you need to separately take up a satellite Iridium data service from Teletrac Navman or another third-party provider. We don't supply this service.

Hardware Repayment Minimum Term: Early Termination Charges (ETC) apply if you cancel your Teletrac Navman solution during a minimum term. The ETC is calculated as: $ETC = \frac{ETC \text{ Base} \times \text{remaining months of the contract term}}{36}$

The ETC Base is set out in Part G – Data Services of Our Customer Terms.

For software

For certain software products which have a minimum term, we may charge you an ETC if your contract is cancelled or terminated (other than for our material breach) before the end of the minimum term. The ETC will be an amount equal to 25% of your fees and charges multiplied by the number of remaining months in your minimum term plus any setup fees (if there are any setup fees which you have not already paid).
