# INFORMATION ABOUT THE SERVICE

Your plan is for an Office 365 Bundle which is available through Telstra's T-Suite® web-based portal.

The Office 365 Bundle consists of:

- The choice to select or combine a Microsoft Office 365 Business plan and/or a Microsoft Office 365 Business Essentials plan, and/or a Microsoft Office 365 Business Premium plan.
- An optional T-Suite Domain Name (either a .com.au or .net.au domain name) which we will configure to your Microsoft Office 365 account.
- Activation of your Microsoft Office 365 account and set-up of up to 5 users.

You need to take up a user licence for each user of the application (User SL). You may purchase up to 300 User SLs for each plan.

# Eligibility

To be eligible for the Office 365 Bundle, you need to separately purchase from us one of the following services:

- a Telstra Internet Direct, Telstra Business Broadband, BigPond® ADSL or BigPond Cable plan
- a bundle which includes one of the above broadband services such as T-Bundle Biz-Essentials® or DOT (Digital Office Technology™)
- a Telstra Mobile Broadband; BigPond Wireless Broadband plan or a Telstra mobile data pack enabled SIM; or
- · a Telstra pre-paid or post-paid mobile.

#### What is T-Suite

The T-Suite web-based portal enables you to purchase and manage various software applications that we make available from time to time.

You need an internet connection to access the T-Suite portal. To start using the T-Suite portal, visit the T-Suite services website and create an account for your organisation.

You may need to meet minimum system requirements to use certain T-Suite software applications, which will be set out on telstra.com/t-suite and Our Customer Terms. You're responsible for ensuring that you meet these requirements.

#### **Minimum Term**

If you take up a bundle with a domain name – 24 months.

If you take up a bundle without a domain name – there's no minimum term

#### Domain name registration and setup

We'll register an optional new .com.au or .net.au domain name for you (or if you have an existing domain name, we'll provide you with instructions on how to configure your existing domain so that you can use Office 365 with the domain name of your preference) and host it for you as part of the T-Suite Domain service. For as long as you keep your plan, we'll contact you before your domain name is about to expire to check whether you'd like us to renew it for you.

# Office 365 as an add-on service to BizEssentials or Telstra Business Broadband

If you take up the Office 365 Bundle as an add-on to BizEssentials or Telstra Business Broadband with a domain, the domain will be registered and hosted for 24 months. Renewal fees will apply after the initial 24 month registration and can be found in the Telstra T-Suite® Applications at store.t-suite.telstra.com

# INFORMATION ABOUT PRICING

### Your minimum monthly charge and total minimum cost

Office 365 Business - \$11.84 per user per month.

If you take up a plan with a domain name, the minimum cost is \$272.32 over 24 months.

Office 365 Business Essentials – \$5.05 per user per month. If you take up a plan with a domain name, the minimum cost is \$116.15 over 24 months.

Office 365 Business Premium – \$12.15 per user per month. If you take up a plan with a domain name, the minimum cost is \$279.45 over 24 months.

### **Early Termination Charge**

If you purchase an Office 365 Bundle with a domain name, and your plan is cancelled before your minimum term has ended, you'll need to pay us an Early Termination Charge (ETC) of \$4 multiplied by the number of remaining months in your minimum term.

There's no ETC if you don't take up a domain name with your plan.
