

Telstra Thanks Absolutely Fabulous Promotion - Terms and Conditions

1. Information on how to enter and prize details form part of these terms and conditions. By entering this promotion you are deemed to have accepted these terms and conditions.
2. This promotion is being run by Telstra Corporation Limited (ABN 33 051 775 556) of 400 George Street, Sydney ("**we**", "**us**" or "**our**").
3. The promotion starts at 9:00am AEST on Monday 18th July 2016]. Entries close and must be received by 4:00pm on Monday 25th July 2016 ("**promotion period**").

Who can enter?

4. Entry is open to Australian residents who are Telstra customers, over the age of 18. Employees or contractors of the promoter and other companies associated with the promotion and their immediate families are not eligible to enter.

How do you enter?

5. To enter, you must, during the promotion period:
 - a) visit Telstra.com/movies or Telstra.com/thanks/competitions and click on the Absolutely Fabulous competition;
 - b) nominate which city (Sydney or Melbourne) you would use the prize
 - c) Complete the entry form in full and submit

("eligible entry").

6. Only one entry per person will be accepted.
7. By entering the promotion, you agree and acknowledge that we (or our agent) may take photos of you and use the photos for our future promotional and marketing purposes without further reference or compensation to you.
8. Entries that are incomplete, incorrect or illegible will be deemed invalid.

Prize

10. There are 8 prizes in total (4 prizes for each of Sydney and Melbourne events) to be won as follows.
 - a) 1 of 4 double passes to the Absolutely Fabulous Movie Premiere in Sydney at the State Theatre on July 31st, each double pass valued at \$200 each (incl GST); or

(each a "**major prize**")

Unclaimed prize draw
