Terms and Conditions

- 1. Information on how to enter and prize details form part of these terms and conditions. By entering this promotion you are deemed to have accepted these terms and conditions.

Who can enter?

4. Entry is open to all Australian residents who are over the age of 18 and are Telstra customers, who hold a valid passport and are able to seek and maintain a valid visa to travel to the USA.
