

Telstra AFL China 2017 Season Launch Promotion – Terms and Conditions

1. Information on how to enter and prize details form part of these terms and conditions. By entering this promotion you are deemed to have accepted these terms and conditions.
2. This promotion is being run by Telstra Corporation Limited (ABN 33 051 775 556) of 400 George Street, Sydney NSW 2000 ("**we**", "**us**" or "**our**").
3. The promotion starts at 9.10PM AEST on Thursday April 13, 2017 to 7pm AEST on Tuesday April 25, 2017. Entries close by 7pm AEST on Tuesday April 25, 2017 ("**promotion period**").

Who can enter?

4. Entry is open to all Australian residents who are Telstra customers, over the age of 18 with an Australian passport with at least 6 months validity and must be able to travel between May 11, 2017 and May 16, 2017. Employees or contractors of the promoter and other companies associated with the promotion and their immediate families are not eligible to enter.

How do you enter?

5. To enter, you must during the **promotion period**:
 - a) Be subscribed as a Telstra customer to the 2017 AFL Live Pass on the AFL Official App
 - b) Stream any live 2017 Toyota AFL Premiership game ("**eligible entry**").
6. Each game streamed for a minimum of one minute is an entry in to the draw.
7. Entries that are incomplete, incorrect or illegible will be deemed invalid.
