

## Telstra Netball GF 2017 Promotion – Terms and Conditions

1. Information on how to enter and prize details form part of these terms and conditions. By entering this promotion you are deemed to have accepted these terms and conditions.
2. This promotion is being run by Telstra Corporation Limited (ABN 33 051 775 556) of 400 George Street, Sydney NSW 2000 ("**we**", "**us**" or "**our**").
3. The promotion starts Round 13 at 7.30PM AEST on Friday May 19, 2017 to 3pm AEST on Sunday May 28, 2017. Entries close end of Round 14 by 3pm AEST on Sunday May 28, 2017 ("**promotion period**").

### Who can enter?

4. Entry is open to all Australian residents who are Telstra customers, over the age of 18 with an Australian passport with at least 6 months validity and must be able to travel between June 14, 2017 and June 18, 2017. Employees or contractors of the promoter and other companies associated with the promotion and their immediate families are not eligible to enter.

### How do you enter?

  - a) Be subscribed as a Telstra customer to the 2017 Netball Live Pass on the Netball Live Official App or have an active Telstra TV
  - b) Stream any live 2017 Suncorp Super Netball game on the app or on Telstra TV ("**eligible entry**").
6. Each game streamed for a minimum of one minute is an entry in to the draw.
7. Entries that are incomplete, incorrect or illegible will be deemed invalid.
